- Shift choices are granted based on Member numbers. Member numbers are given to each member upon receipt of application including payment.
- Shift choices must be submitted no later than THE FRIDAY AFTER the previous tournament. For example, shift choices for the Metro Doubles KO must be submitted by Friday, August 14th (which is the Friday after the Cape Ann Singles KO).
- If a shift time must be changed, it is the bowler's responsibility to make the change. A list of shift times and names can be provided, but we will not take on the responsibility of getting your shift time changed for you. If you find another bowler to change shifts with, we must be notified by you AND the other bowler, otherwise the shift change will not be granted.
- Payment for each tournament is due upon arrival that day. Please do not try to pay in advance.
- Payouts will be done at the conclusion of each tournament (we can mail a check upon your request).
- ICBA Rulebook will be used for reference. The Pro Series committee will handle all grievances. The committee consists of five members: Mike MacIntosh, John Zappi, Jeff Surette, Dave Barber and Dan Allard.
